# August 2006

# Aug 15th: Further N3ET Reports Now Available!

- The work on Recommendation 25 has been completed and the two reports prepared for the Australian Health Ministers' Advisory Council on (1) Scholarships and (2) Re-entry have now been accepted and are now available for dissemination to N<sup>3</sup>ET stakeholders.
- Following a period of consultation, the final version of the **National Specialisation Framework** for **Nursing and Midwifery** is now available.

# Aug 10th: Recommendations 7/35 Report Available!

The *Implementing minimum qualifications and suitability checks for the direct care workforce* report is now available.

The findings of this report stem from two phases of work conducted by the Taskforce on care workers for a national nomenclature, minimum Certificate III qualifications from the Health or Community Services Training Packages and suitability checks for unregulated Direct Care Workers (DCWs) by 2008.

#### July 24th: National Nurse Prescribing Glossary

National Nurse Prescribing Glossary (NNPG) and Taxonomy of Nurse Prescribing and Initiating is now available. It provides a comprehensive and contemporary picture of nurse prescribing and nurse and midwife initiating practices, captured at a point in time when nurse prescribing is developing nationally. It includes 18 terms associated with the initiating and prescribing of medicines by nurses and midwives and a taxonomy for classification of initiating and prescribing models nationally.

# July 13th - QUT receives ARC grant for Nurse Practitioner (NP) project

The National Nursing and Nursing Education Taskforce (N³ET) congratulates the research team based at Queensland University of Technology for their success in the recent round of Australian Research Council (ARC) Linkages Project grants. The project team will undertake a three-year study into nurse practitioners (NPs) entitled "Reforming healthcare: Nurse Practitioners and workforce re-design". The study will be a unique opportunity to profile the progress, process and outcomes of nurse practitioner service nationally.

#### The research team of:

- Professor Glenn Gardner (Queensland University of Technology)
- Associate Professor Anne Gardner (Deakin University)
- Professor Sandy Middleton (Australian Catholic University National (NSW), and
- Dr Phil Della (Health Department of Western Australia)

will join with the Chief Nurses, N³ET and Australian Nursing & Midwifery Council as "industry" partners, to undertake this important health service research.

In ARC Linkage Projects, collaborating organisations and partner organisations provide support (financial and/or in kind) to the research team, thus fostering links between universities and industry. The considerable work undertaken by N³ET over the past two years into NPs will provide a valuable resource for the researchers.

#### July 12th: Progress on Recommendation 4 - Nationally Consistent Scope of Practice

July 4th: Pathways to Progress Nurse Practitioners (NPs)

An interim report on Report on Recommendation 12, National Review of Nursing Education (2002) – Our Duty of Care – Maximising Education Pathways for Nurses and Midwives.

Ten principles have been developed to drive greater national consistency in the educational pathways for nurse practitioners in Australia. They are intended to give direction with supporting rationale to all jurisdictions, not only those yet to implement the NP role. It builds upon the recognised diversity in the Australian health workforce and in particular the career and lifestyle choices of nurses and midwives. The principles acknowledge that Australia is in a transitional phase at present, but that it is timely to focus on consistent national direction, one that firmly positions the role for the next decade.

In 2005, N³ET convened five Work Groups to undertake work on Recommendation 12. The purpose of the work groups was to bring together representatives of the key stakeholder groups to work collaboratively and assist in strategically addressing education needs of the future in a flexible and collaborative manner by proposing strategies and approaches to address the limitations of existing articulation pathways for nurses and midwives; and developing nationally consistent approaches to recognition of prior learning and current competence in enrolment processes for nurses and health care workers.

One work group was asked to consider **educational pathways for NPs in Australia** and to identify issues stemming from differences in levels/requirements for educational preparation and identify strategies, options and opportunities for greater national consistency in the educational preparation of nurse practitioners. The working group met between September 2005 and March 2006. It considered a range of issues related to issues stemming from differences in levels/requirements for educational preparation and identified strategies, options and opportunities for greater national consistency in the educational preparation of nurse practitioners.

In particular, ten principles have been developed that should be adopted by jurisdictions when making decisions about the minimum educational requirements for recognition as an NP.

These principles will ensure that:

- Diverse and inclusive pathways to NP level are available
- Greater national consistency in entry to practice educational requirements for NP is achieved, and
- A balance is reached between an educational level that engenders public confidence and one that is able to justify a direct link between the restrictions imposed and harm reduction.

The Atlas provides a detailed and contemporary snapshot of the similarities and differences in legislation and policy that supports particular aspects of the professional regulation of nurses and midwives in each of the jurisdictions in Australia.

#### Commonwealth funding for clinical practicum

The Commonwealth Funding for Clinical Practicum report is a report on Commonwealth funding to support clinical practicum for undergraduate nurses and midwives in Australia (Recommendation 24: National Review of Nursing Education (2002) Our Duty of Care report).

This report shows that as nursing is a National Priority Area in education for the Australian community, it is essential that additional Commonwealth funding to nursing programs is continued and forms a permanent part of the baseline funding for this discipline cluster, so that the higher education sector can continue to educate nurses in light of predicted demand.

As the costs of clinical practicum continue to spiral, more detailed review of the baseline level of funding is merited to arrive at a sustainable funding level that balances the pedagogical needs of students with the regulatory requirements for licensing and the work readiness concerns of employers. Clearly the needs of health consumers should also have a voice in this dialectic. In the complex interface between health and education, it is likely that funding policy will form one strand of a strategic approach to clinical practicum for undergraduate nurses. There would also be benefit in unpacking the complex and interrelated factors driving the spiralling costs of nursing programs.

### May 9th: Media and Communication Principles Nursing and Midwifery

Media and Communication Principles Nursing and Midwifery have changed considerably over the last 50 years.

Developments in technology, shifting community demographics, the move to university education and the emergence of new allied health roles have all contributed to the constantly evolving role of nurses and midwives in the community.

The value, contribution and benefits of a nursing or midwifery career need to be promoted to improve the portrayal of and communications about nursing and midwifery in the future.

The National Nursing and Nursing Education Taskforce (N³ET) worked with a group of media and communications experts to develop a set of communication principles and a national marketing profile (brand) for nursing and midwifery for this purpose.
